

Imaging Services Terms of Use



Use of images is granted by the Chancellor Master and Scholars of the University of Oxford on behalf of its Bodleian Libraries.

The Bodleian Libraries aim to support and facilitate research, learning, teaching and engagement with its collections, for the widest possible audience. The terms of use described here will apply to the majority of the Bodleian Libraries content, but some may have restrictions or may belong to others and therefore users must check the individual terms of use for each item before reusing the content.

These terms of use set out the conditions for use of the content purchased through the Imaging Services department.

These terms of use do not grant users any rights to use the names, logos or trademarks of either the University of Oxford or the Bodleian Libraries.

When reusing images sourced from the Bodleian Libraries collections – where user distribute, disseminate or communicate the content in any context - the user must (wherever possible) acknowledge the source of the content by including (at least) the following information: [holding institution, shelfmark, folio]. E.g.: “The Bodleian Libraries, University of Oxford, shelfmark, folio”.

Users must:

- include any relevant copyright notice provided by Imaging Services on the content
- refer to the Creative Commons licence CC-BY-NC 4.0.

Further copyright, data protection and privacy laws may still apply to content. You must comply with all terms or restrictions other than copyright (such as trademark, publicity and privacy rights, or contractual restrictions) as may be specified in the metadata or as may otherwise apply to the Content.

It is your responsibility to determine and satisfy copyright and other use conditions in the country in which you are accessing the content before copying, transmitting, or making other use of Bodleian content. These terms contain general information based on English law and, although we endeavour to ensure that the content is accurate and up to date, users should seek appropriate legal advice before taking or refraining from taking any action.

Where our site contains links to other sites and resources provided by third parties, these links are provided for your information only. Such links should not be interpreted as approval by us of those linked websites or information you may obtain from them. We have no control over the contents of those sites or resources.

The Bodleian Libraries reserve the right to update these terms of use at any time. Each time you wish to apply for the use of Bodleian Libraries images, please check these terms of use to ensure you understand the terms that apply at that time.

In order to help users understand the types of use that are encouraged or prohibited, further details on permitted and non-permitted uses are outlined below.

PERMITTED USE OF THE CONTENT

The Bodleian Libraries wish to encourage wide engagement and reuse of collections for the purposes of private study, research, teaching, and educational instruction. This means that, unless indicated otherwise in an individual item's terms of use (such as the relevant Creative Commons licence), users can use images from the Bodleian Libraries collections in the following ways:

- Personal use of content for non-commercial research and private study;
- Educational use of content by a student in course-related work (including dissertations and theses);
- Educational use of content for the purpose of teaching and instruction within an educational establishment or closed group online teaching;
- Educational use of content in presentations at educational conferences and closed group online conferences;
- Use of content in academic books/textbooks/e-books with print runs up to and including 3,000 copies. Restricted to inside use only (book jackets and book/e-book covers are subject to commercial conditions);
- Use of content in journals/e-journals and academic newsletters. Restricted to inside use only;
- Academic and research-orientated websites (including institutional/subject repositories and pre-print servers), apps, blogs and social media channels that are not linked to the promotion of any commercial activity;
- Reproduction of images to promote an exhibition to which the Bodleian is a lender.

This list is not exhaustive but is intended to illustrate the Bodleian Libraries' wish to encourage reuse of Bodleian images for academic and scholarly endeavour. Image requests for academic use may be available on [Digital Bodleian](#).

Personal use includes self-photography, but these images cannot be used for reproduction in any publication, except theses.

Images for publication purposes, academic or commercial, are to be purchased from Imaging Services.

PROHIBITED USE OF THE CONTENT

The Bodleian Libraries restrict the commercial use of collection images without obtained permission. This means that images cannot be used for commercial purposes without the granting of the necessary permissions and payment of the appropriate licence fees. This

restriction is in place in part because the Bodleian Libraries seek to protect the commercial partnerships and activities based on images of our collections that provide an income stream that supports the work of the Bodleian Libraries, including our digitisation efforts.

Image requests for licenced and other commercial use may be available on [Bodleian Images](#). Users cannot reuse images obtained from Bodleian Images for any other use than the specific licence permits.

Commercial purposes means any use of the content that is primarily intended for or directed toward commercial advantage or monetary compensation. This includes any use on or in anything that is itself charged for or is intended to make a profit.

In addition, you must not:

- subject the content to distortion, mutilation or other derogatory treatment of the author, in accordance with the Copyright, Designs and Patents Act 1988, or of the Bodleian Libraries;
- use any content in a manner which may suggest that you are a part of, or otherwise associated with, the University of Oxford, or any other body associated with it; or
- use any part of the content for purposes which might adversely affect the image, reputation, goodwill, distinctiveness or prestige of the University of Oxford or the Bodleian Libraries or its collections.

As outlined above, the use of Bodleian Libraries images is permitted in an academic publication. As a guideline, the Bodleian Libraries consider academic publications to be academic books/textbooks/e-books with print runs up to and including 3000 copies, and to journals/e-journals and academic newsletters. This permitted use applies only to images used inside a publication, and commercial restrictions apply to publications with a print run of over 3000, and to the use of images on book jackets and e-book covers.

Other examples of commercial uses which require permission for use and payment of appropriate fees include use in: newspapers and magazines; broadcast media; commercial websites, apps, blogs and social media channels, including those of the trading arms of charities, that are used as a platform to promote or conduct commercial activities (for example to sell products or services); exhibitions and displays; exhibition-related books and catalogues; advertising, marketing and promotional materials (print and digital); commercial products and packaging; displays in commercial outlets.

RESTRICTED USE OF THE CONTENT

This is a non-exhaustive list of the Bodleian Libraries content where users need to obtain permission to reproduce from its respective owners and/or keepers prior to contacting Imaging Services to request licence to use:

- Oxford college material

- Tolkien material

DURATION OF PERMISSION

For printed use, the duration (term) of permission will be the duration of the print run or life of edition as appropriate.

For electronic use the term of the license is 2 years from publication.

DATA PROTECTION AND PERSONAL DATA CONCERNING LIVING PERSONS

When using our archives and manuscripts you must:

- respect the confidentiality of any data subject (assuming a lifespan of 100 years)
- not identify data subjects without their permission
- not use personal data in such a way as to damage or cause distress to any data subject
- not use personal data to support measures or decisions in respect of living people
- anonymise identities whenever possible when note-taking, and in the results of your research
- be aware that you are responsible for compliance with the Data Protection Act 2018 in relation to the secure storage and processing of any personal data obtained from the Libraries' collections. You must dispose of this data in an appropriate manner when it is no longer required for your research.

COPYRIGHT OWNERS

Imaging Services operates under the constraints of UK Copyright Law.

A work is in copyright for 70 years after the death of the author. Although a text may no longer be in copyright, an edition of that text involving contribution from an editor or a translator will have a new copyright, which will last for 70 years after the editor's or translator's death.

Unless the item you wish to copy is out of copyright, or you have the written permission of the copyright holder, it is advisable to stay within the following limits:

- One copy of one article in a serial publication or in a set of conference proceedings or in a collective work.
- One copy of one complete chapter from a book.
- One copy of one case report from a law report.
- Up to 5% of a physical volume of any of the above (which may be greater than one article, chapter or report, or may include extracts from more than one article, chapter or report).
- One short story or poem in a collective work, up to ten pages in length.

Requests for complete reproduction of material beyond these limits will require written copyright permission from the copyright holder before Imaging Services will accept the order form.

Illustrations are separate works in their own right, with separate copyright. If they are in copyright they may not be copied separately. They may only be copied if the copying is incidental to the copying of the text in which they occur. As well as pictorial and photographic works, graphs, charts, maps, diagrams and technical drawings all count as illustrations.

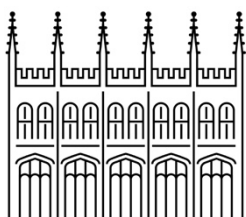
