

ORA is heavily crawled by Google and other search engines.

Preservation: ORA provides the means to preserve your research for the long-term.






A PDF version of the work should also be added to the archive as the **DISSEMINATION** copy. This is the file that will be made available on ORA.

Completed Research datasets (any type of data) can be deposited with ORA, and a record created within ORA. This dataset can be assigned a DOI.



The ORA Data record and the Thesis record can be LINKED together as related items.





Hardcopy theses

Post Graduate Research (PGR) theses are <u>no longer</u> required to be deposited in hardcopy to the Bodleian Library via the Exam Schools.

Successful D.Phil., M.Sc., and M.Litt. students are required, on the granting of leave to supplicate, <u>only</u> to submit an electronic version of their finalised thesis to ORA (Oxford University Research Archive).

The exceptions are students who have been granted permanent dispensation from consultation of their entire thesis and students whose thesis (or parts thereof) is in a non-standard format which cannot be submitted electronically (e.g. a 3D artwork, or artefact) – these students should also submit a physical copy for deposit.

Copyright

Generally the author holds the copyright for their thesis. However a thesis may often include material (e.g. images, graphs, photos, etc.) for which copyright may be held elsewhere. This material is known as 'third party' copyright.

Permission should be obtained from the copyright holders for third party material before it can be made available in ORA.

Material where permission cannot be obtained should be removed from the dissemination copy of the thesis.

From published work: 'fair dealing' may apply (quotations, short excerpts), otherwise permission from the copyright holder is required (maps, music, extensive excerpts, etc.).

From unpublished work (other thesis, research groups): permission must be obtained from the copyright holder


Fair Dealing

The law allows the use of quotation from a work for quotation, criticism or review

- 1) The purpose is really for quotation, criticism or review
- 2) The material used is available to the public
- 3) The use of the material is fair
- 4) Where practical, the use is accompanied by a sufficient acknowledgement
- 5) Your use of the quotation must extend no further than is required to achieve your purpose

There is no statutory definition of fair dealing!!!!




Figure 1.1: Three example kinks. (a) Kink in cytochrome b₅₅₉. Reprinted from Biochimica et Biophysica Acta (BBA) Biomembranes, 1818, Weber, Tome, Otzen & Schneider, A Ser residue influences the structure and stability of a Pro-kinked transmembrane helix dimer, 2103-7, Copyright (2012) with permission from Elsevier. (b) The kink in the sixth transmembrane helix of a GPCR (PDB code 2rh1). Residues around the kink are highlighted in red. (c) Kink in the amyloid precursor protein. Reproduced from Barrett et al. (2012). Reprinted with permission from AAAS.

Making changes to your thesis after submission

It is not possible to make changes to your thesis, including fixing mistake or providing supplementary materials, after Leave to Supplicate has been granted

LTS is the formal endpoint for corrections or clarifications to be made, with sole exception of issues of misconduct.

This includes your entire thesis, including sections such as acknowledgments.

The only changes that can be made are redactions, via the Dispensation from Consultation process.

The Oxford University Research Archive (ORA) serves as the institutional repository for the University of Oxford and is home to the scholarly research output of its members. ORA is also the home of Oxford digital theses.

It is a mandatory requirement for all students following programmes of study, at D.Phil., M.Sc. (by Research) or M.Litt. to deposit your thesis in physical form to the Bodleian Library and electronically to ORA.

Theses from other programmes of study may be eligible for inclusion in ORA on a voluntary basis.

In this task, we will use ORA to find thesis and journal article records. We will then look at how you would obtain copyright permission to make third party copyrighted material included within your thesis available online via ORA. Imagine that you are writing a thesis on astronomical phenomena. Your supervisor has suggested reading an interesting thesis by a past Oxford student, which may be available on ORA.

The Search Bar is on the top centre of the screen, above 'Top Downloads' and 'Latest Additions to ORA'.

You can use "inverted commas" to narrow your search. Further searching ORA guidance can be found on the ORA Libguide (http://ox.libguides.com/searching-ORA)

Find and explore the thesis record

Click on the title 'Massive black hole remnants of the first stars and their significance in presentday galactic halos' to enter the thesis record.

Inside the ORA Record, you can see the abstract, bibliographic data, a link to download the thesis file and statistics on the number of times the record has been viewed and downloaded.

Reading this thesis has sparked new directions for your research, and you now wish to find an article on high energy cosmic rays, that was written by an Oxford academic and so may be available in ORA.

Go into the journal article record 'Cosmogenic photons as a test of ultra-high energy cosmic ray composition'

You can use the search bar from within an ORA Record.

You wish to use a figure from this article in your thesis. Before you can make any third party copyright material (e.g. images, graphs - including those you adapted, large excerpts of text, etc., that have been used in your work from another individual's work or creation) freely available online you should obtain permission from the copyright holder(s) to distribute their material in this way.

Go to the Publisher webpage for that article

In the ORA Record, find the Publisher copy link on the right hand 'links and downloads' menu



Click on 'Get rights and content'

On this website, this is in the centre of the screen above the article text.

This opens Rightslink®, a tool allowing you to gather permissions fast and easily.

Select 'reuse in a thesis/dissertation'

Complete the form and select 'quick price'

This will tell you how much permission costs - reuse in a thesis is almost always free.

Once your thesis has been examined and you have received Leave to Supplicate (LTS), you must deposit your own thesis with ORA in order to graduate.

This also provides a means for institutional compliance with funders' Open Access requirements.
