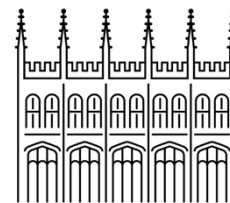


Making digital copies

The following is guidance for making digital copies under the CLA licence..

Coverage	Use the check permission tool to check if the material is eligible for scanning? https://www.cla.co.uk/higher-education-licence	<input type="checkbox"/>
Ownership	Check SOLO to see if the University owns a copy of the material. Copies held in college libraries are sufficient for the licence. If no copy is owned it cannot be scanned.	<input type="checkbox"/>
Digital Version	Is a digital version already available? Then don't make a scan and provide a link instead.	<input type="checkbox"/>
Extent limits	Does the digital copy follow these limits? For each course/reading you can copy one: <ul style="list-style-type: none">• Book chapter• Article from journal issue• Scene from a play• Paper from a set of conference proceedings• Report of a single case from a volume of judicial proceedings• Short story, poem or play from an anthology (must be less than 10 pages) OR <ul style="list-style-type: none">• 10% of the total publication Whichever is greater.	<input type="checkbox"/>
Copyright Notice	Have you attached a Copyright Notice to the pdf?	<input type="checkbox"/>
Sharing	If you are sharing via a VLA (e.g. Canvas), is the site password protected and have you added the copyright notice?	<input type="checkbox"/>
Reporting	All digital copies have to be logged and reported to the CLA. Have you logge the digital copy on your local CLA HE Digital Record Form?	<input type="checkbox"/>
Weeding	At the enf of the academic year, have you removed any digital copies that are no longer needed or covered by the Licence?	<input type="checkbox"/>

Making digital copies: frequently asked questions

Does the edition I use matter?

No but you cannot exceed the 10% limit. So if you copy 10% from the 1st edition you cannot copy any more from any other editions.

Do I have to report images?

Disembedded images (where a page is scanned and only an image on the page is used) do not need to be reported if they are scanned from a print copy covered by the CLA. Copies can still be made of pages with images and text, as well as book covers, but these need to be reported as normal.

Is there a difference between scanning and photocopying?

Yes. Some titles are only eligible for photocopying and not for scanning. Use the check permissions tool to see if the title you want is covered for photocopying and scanning.

Do I have to report photocopies?

No. Photocopies made for course packs do not have to be reported, only digital scans.

Why are titles published in US different?

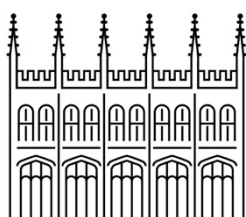
US works need to be expressly opted in for scanning, and even then, only if there's no digital version commercially available.

Excluded categories

Workbooks, newspapers, maps, charts and printed music are all excluded under the CLA Licence. If they need to be copied other permissions must be sought. The University also holds a NLA Licence, which covers copying from newspapers for teaching and media monitoring purposes.

Copyright Fee Paid copies

Although it is recommended that the University own a print copy of all scanning source material, this is not always possible. For rare and out of print material a scan can be made from a Copyright Fee Paid copy usually obtained via Inter Library Loan. The Copyright Fee Paid status effectively adds the copy to our library collections and makes it eligible for distributing under the CLA Licence. The fee paid status must be indicated on the notice attached to the scanned copy to provide confirmation that the copying was legal and clarify the purposes for which the fee paid applies.
